## Categories of Membership

AMWA has the following categories of membership to cater for different types of members. Please ascertain which category of membership you fall under and tick the appropriate box in the application form:

### 1. Individual / Family Member

Citizens, former citizens and permanent residents of Malaysia, who the Executive Committee considers to be in good standing and who are ordinarily residents in Western Australia, qualify for this category of membership. Family membership includes spouses and dependent children under 18 years of age. The member and spouse shall each be entitled to one vote in any election pertaining to the affairs of the Association.

### 2. Student Member

Malaysian students above 18 years of age studying full time or apprenticed in Australia, who the Executive Committee considers to be in good standing and interested in educational, social, cultural, sporting, economic and other activities relating to Malaysia whilst residing in Western Australia as students.

### 3. Associate Member

All other individuals who do not fall into either categories 1 or 2 above, who the Executive Committee considers to be in good standing and are attached to any corporation, organisation or society who has an interest in Malaysian affairs.

### 4. Corporate Member

Companies, corporations and incorporated organisations who have been incorporated or established under the laws of Malaysia and who have a place of business or some form of recognised legal presence in Australia, as recognised by the laws of Australia.
